Introduction

The Consortium of Institutes on Family in the Asian Region (CIFA), an independent non-profit making organization registered under laws in Hong Kong, aims to serve as a regional hub for networking with similar organizations / interested professionals with the mission of 'Converging Professional Wisdom for Family Well-Being'. The goal is to strengthen family functioning and promote family health in the region while contributing to the body of knowledge in relationship science in the international arena. Its function is to support and enhance mutual interest in research and training initiatives, and to share clinical experiences and policy formulation on families that are unique to the Asian region.

Objectives of 3A Project

The 'Asian Award for Advancing Family Well-Being' ('3A Project') is presented to projects that have advanced an innovative idea, model, or paradigm that could improve the quality of life for families and enhance their well-being.

The aims of this project are to provide an opportunity to promote CIFA as a regional platform, encourage sharing of valuable experience which can be applied in developing family work in the region through active participation, and give recognition to outstanding and innovative work that truly reflect the mission of CIFA in "Converging Professional Wisdom for Family well-being". Thus, emphasis is laying the foundation and creating the momentum among professionals in different countries which will ultimately contribute to the sustainable development of the whole Asian region.

Specific Objectives:

- To promote and identify outstanding and innovative projects
- To introduce the awarded projects to other countries
- To review the suitability and sustainability of the transferred knowledge
- To develop a handbook/guideline

Project themes:

- Promoting and Enhancing Family Functions
- Encouraging cross-sector/professional collaboration
- Supporting families at special circumstances
- Embracing changes for family sustainable development

- > Who are the current and potential beneficiaries of the project?
- > Who are and what is the nature of the partnership?
- > How was the partnership formed?
- > What are the achievements?

Award Eligibility

- Projects by Full Members of CIFA or nominated by them in the Asian Region.
- Projects completed with evaluation conducted no more than two years before the submission deadline.

Entry Rules & Procedures

- Application should be submitted to CIFA office for indication of interest.
- Initial entries to be submitted in English with a synopsis of 500 words for first round screening.
- For the second round, short-listed entries to be presented in print format (with a maximum of 5000 words, including text, figures, tables and appendices).
In addition, audio-visual format with a maximum of 30 minutes are acceptable.
- An entry can be submitted by an individual or a group, with each one submitting only one project.
- Whether published or not, entries must be original.
- CIFA reserves the right to use submissions for non-commercial purposes in promoting the 3A project and promoting family work.

Adjudication

To ensure the high standing of the award, the adjudicating panel comprises the chairperson and committee members of CIFA Council, the representative of the sponsor of this Award and respectable professionals in the related field.

There will be 3 rounds of adjudication as following:

- First round assessment will be done by screening all the initial entries to short list 15 entries for second round.
- Second round adjudication will be conducted through tele-interview to short list 8 projects to enter into the final round.
- Representatives of the 8 finalists will be invited to attend the CIFA symposium in Japan to present the project for final adjudication.

Selection Criteria

A. Rationale and Social Responsiveness:

- Well defined and concrete objectives
- Timely identification and response to the needs of the families in respective countries

B. Work approach and implementation process:

- Well justifiable and distinctive approach
- Demonstration of how the service process results in the achievement of outcome

C. Effectiveness:

- Achievement of outcome and appropriate use of outcome measurement tools
- Effective utilization of manpower, financial & community resources
- Long-term impact & sustainability

D. Consolidation of knowledge/practice wisdom:

- Clear analysis and documentation of critical success factors
- Clear delineation on the future applicability of the practice

E. Innovation:

- Demonstrate creativity in programme design and content

F. Institutional synergy:

- Promote multi-disciplinary/cross-service cooperation which brings benefits to the families
- Enhance cross-country collaboration which has positive impact on mutual sharing and exchange.

Results

The decision of the adjudicating panel is final and irrevocable. The organizer will not disclose the contents of the adjudicators' deliberations. The result of the competition will be announced at the CIFA Regional Symposium in November 2010 in Japan when an award presentation ceremony will be held.
